

Camping Information 2014

All vehicles used to transport livestock and/or RV's must have a valid auto pass. Upon arrival, the license plate number will be written on the pass. The pass and the vehicle must match for it to be valid. Any vehicle without a valid vehicle pass will be towed at the owner's expense. Due to limited parking on grounds, livestock passes will be limited to one (1) per family.

Only livestock &/or horse exhibitors will be allowed to have dogs on the Fairgrounds in camping areas as well as in the livestock &/or horse barns, but under NO circumstances will dogs be allowed south of the barns.

For safety reasons – No vehicles will be allowed to park in the camping area by the barns. However, vehicles will be allowed to park in this area to unload supplies during specified times only, which are 8:00 pm to 10:00 am.

THIS WILL BE ENFORCED!

Things to remember while at the 2014 ND State Fair:

Absolutely NO camping spaces will be used for parking of vehicles.

Campers must have a valid camping permit clearly displayed at all times.

No gray or black water dumping is allowed on site except by a contracted pumper. Please contact the camping office, located on the 2nd floor of the Heritage Hall, for your pumping and filling needs. Requests must be made by 4 pm the day prior for the next day service.

Electrical services, by the barns 30 amp, west lot 20 & 30 amps. Please be courteous to draw no more than 20 or 30 amps during peak times. Circuits will overload and the service will be disconnected.

Please bring at least 100' extension cord to reach electricity adequately.

Showers are available in the Expo Barn, the Bunny Barn, the Block Bathrooms by the Midway, the State Fair Center and in West Lot Campground.

Quiet time – 11:00 pm to 7:00 am

Campers are responsible for picking up their own garbage.
